## **Minor Accommodation Consent**

- 1. Minors (under the age of 19) can only stay with the consent of a guardian or accompanying guardian.
- 2. In the case of false information or counterfeiting of the consent of minors, civil and criminal liability shall follow according to the relevant laws. Also, this consent must be filled out and signed by the guardian of the minor who is planning to stay.
- 3. The guardian must be a legal representative (parent or guardian) under the Civil Act.
- 4. Please fax or mail a photocopy of this consent form and the guardian's picture ID before your stay.
- 5. Documents to be submitted for accommodation are as follows: Please present it to the front desk upon check-in.
  - \* If the documents are incomplete, you will not be able to stay.
  - √ 1 original copy of minor accommodation consent
  - √ A copy of the guardian's ID
  - √ A copy of a family relationship certificate showing the relationship between the guardian and the minor
- 6. <u>Minors cannot cohabit with the opposite sex</u> even if this consent is provided. Please note that if this behavior is confirmed, you will be forced to leave.
- 7. Underage drinking and smoking are prohibited by law. Please note that if this behavior is confirmed, you will be forced to leave.
- 8. Refunds are not available even if you are forced to leave in violation of No. 6 or 7.
- 9. All problems that occur after entering the room are the responsibility of the guardian, and we are not responsible for any loss or damage.
- 10. Before the stay, we will confirm the contents of this agreement to the guardian over the phone. The minor can check-in after confirming over the phone.
